

## Pueblo County Fair & 4-H Superintendent Application

4-H and Pueblo County Fair Superintendents provide input, guidance and help interpret Pueblo County Fair/Pueblo County 4-H competition rules in cooperation with CSUE staff and the Pueblo County Fair Board. Superintendents serve in both 4-H and Pueblo County Fair capacities, unless otherwise directed by CSUE and the Fair Board.

Superintendents are supportive members of 4-H and the Pueblo County Fair and are expected to follow the 4-H Code of Conduct and Pueblo County 4-H Policies at all times. Please note that Superintendents are based on the needs of the 4-H Program and that of the Pueblo County Fair, and can expand/retract based on current enrollment, program need, etc.

- November 6 December 4: Open application period.
- December 5 8: Selection Committee meets and makes decision on applicants, and successful
  candidates notified.
- January 1: Superintendents assume their roles.
