Please note that Superintendents are based on the needs of the 4-H Program and that of the Pueblo County Fair, and can expand/retract based on current enrollment, program need, etc.

- December 5 - 8: Selection Committee meets and makes decision on applicants, and successful candidates notified.
- January 1: Superintendents assume their roles.
